





HISTORY, FACTS AND ISSUES: The Solicitor-General's Office has received VOCA funds since April 01, 2014. This grant allows the Solicitor-General's Office to continue to provide services to victims earlier in the criminal justice process, essentially prior to the defendant's first appearance as well as help victims secure restitution through GA Crime Victims Compensation Fund Program. The match will continue to be satisfied 100% In-kind through the use of Volunteer/Intern hours. Again, there is no cost to the county. 


