MINUTES

The minutes were presented for the work session of February 12, 2018, and the regular session of February 13, 2018. No changes to the minutes were requested.

APPOINTMENT

Department of Behavioral Health & Developmental Disabilities Board (DBHDD), County Manager, Joe Pritchard, presented the appointment. Due to the resignation of Chris Yarbrough, there is a vacancy which needs to be filled. Mr. Pritchard stated Ms. Kelley Saxon has expressed an interest and is in the audience this morning. Commissioner Evans and Chairman Slaughter asked Ms. Saxon to come forward. Ms. Saxon spoke to the commission regarding her background.

FOR CONSIDERATION

Computer Hardware and Software Bulk Purchase, IT Director, Aaron Kostyu, presented this item for the final purchase for the computer hardware and software bulk purchase for the fiscal year in the amount of \$28,429.24.

Email Server Software and Client License, IT Director, Aaron Kostyu, presented the item for the email server software and client licensing to support 2016 exchange email environment and support. Commissioner Griner asked if this item was budgeted to which Mr. Kostyu replied yes. The cost is \$31,892.53.

Purchase of Computer Servers, Software and Storage, IT Director, Aaron Kostyu, presented the item stating the Tyler New World Public Safety software project will require a redundant hardware environment to ensure uninterrupted access to life critical applications and data. The cost is \$179,977.80.

Replacement Server Blade Purchase, IT Director, Aaron Kostyu, presented the item stating the current server blades will run out of technical support by July 2018 and the servers host all of Lowndes County's communication applications. Chairman Slaughter asked Mr. Kostyu if the four items he presented could be approved under one motion, Mr. Kostyu stated yes. The cost is \$31,581.80.

2-1 Ton Dual Wheel Truck with Service Body for the Utilities Department, Utilities Director, Steve Stalvey, presented the item solicited by our purchasing department, to replace older vehicles within the department. County Manager, Joe Pritchard, stated in order to have a comparison, due to only receiving one bid from the Langdale Ford Company, our purchasing department reviewed the State of Georgia bid pricing and this bid was lower than the state. The total cost is \$85,100.00.
