Chairman Slaughter called the meeting to order at 8:30 a.m.

MINUTES

The minutes were presented for the work session of March 27, 2023 and the regular session of March 28, 2023. No revisions to the minutes were requested.

RECOGNITIONS

National Animal Control Officer Appreciation Week

County Manager, Paige Dukes, asked the Director of Animal Services, Linda Patelski and the Assistant Director of Animal Services, Mike Brown, to share with the Commission the daily work of the officers. Mr. Brown thanked the Commission and the County Manager for their support. Mr. Brown stated the veteran officers are certified with two new officers beginning certification in the future. Additionally, Mr. Brown stated the Animal Control Officers attend schools to educate the children, as well as school staff, regarding enforcement and resources within the community. Mrs. Patelski stated she is proud of all of her staff and commended all of them for a job well done. Additionally, Mrs. Patelski thanked the Commissioners for being an advocate for their office.

National Public Safety Telecommunications Week

County Manager, Paige Dukes, asked 911 Director, Danny Weeks to address the Commission. Mr. Weeks thanked the Commission for their support and providing the resources needed to do a good job. Assistant 911 Director, Tonya Davis, spoke regarding the 911 Center's call volume and stated their office is Georgia POST (Peace Officer Standards and Training) certified and can receive emergency and nonemergency calls and dispatch for Lowndes County and Echols County with the exception of state agencies, Valdosta State University and Moody Air Force Base. Mrs. Davis stated the

911 Center has received approximately half a million calls this year, not including the radio call volume. Mrs. Davis stated she's very proud of the staff and the work that is done on a daily basis. Chairman Slaughter thanked Mr. Weeks, Mrs. Davis and their staff in attendance, for their work and stated their office is "the first" of the first responders, to deal with the citizens calls and dispatch to the correct departments. Chairman Slaughter also commended their office for the continued CALEA certification throughout the years and wished them continued success.

APPOINTMENTS

Lowndes County Board of Health

County Manager, Paige Dukes, presented the item. Dr. Randy Smith's term has expired and he has not expressed a desire to continue to serve. Mrs. Dukes stated Ms. Brenda Mims has been recommended for the seat.

Valdosta-Lowndes County Zoning Board of Appeals (ZBOA)

County Manager, Paige Dukes, presented the item. Mrs. Dukes stated there are two County Zoning Board of Appeals members whose terms are expiring on May 7, 2023. Mr. Marion Ramsey and Ms. Victoria Copeland have both expressed a desire to continue to serve.

South Georgia Regional Library Board

County Manager, Paige Dukes, presented the item, Mrs. Dukes stated Dr. Darlene Ridley has stated she will no longer be able to serve on the board. Ms. Jane Peebles would like to be considered for appointment to fill the unexpired term.

Chairman Slaughter reminded the Commission if they had other applicants to be considered for serving on the boards, to have them complete the online appointee/information sheet before tomorrow night's meeting.

PUBLIC HEARING

REZ-2022-10 The Campus Transitional Care Facility, 2193 Howell Road, E-A to P-D, Well & Septic, ~23 acres,

County Planner, J.D. Dillard, presented the item. Mr. Dillard stated this request is to rezone from E-A to P-D, in an agricultural-character area with some wetlands on the north end of the property. Mr. Dillard stated the Planning Commission recommended denial.

FOR CONSIDERATION

Probation Department Service Agreement

Probation Director, Ferlisha Rountree, presented the Probation Department's Service Agreement required by the Misdemeanor Probation Oversight Unit (MPOU) for probation service provided by Lowndes County Probation. Mrs. Rountree stated the Probation Service Agreement is valid for a five-year period. Mrs. Rountree stated there are two

changes in the agreement; the effective date is July 1, 2023 and regarding the number of probationers supervised, it has been changed from 350 to 250. Commissioner Marshall asked regarding the probationers who are unable to pay, Mrs. Rountree responded if someone is unable to pay, there is a walk-in revocation hearing and at that time they can present their financials to the judge. Mrs. Rountree stated there are options like converting the fine and/or probation fees into community service or the judge may terminate the case. County Manager, Paige Dukes, stated a common misconception by the community is related to how much authority the probation officers have. When someone goes to court and the judge places them on probation, the judge signs an order and on that order is listed everything that needs to be done to meet probation requirements. Lowndes County Probation has no legal authority to amend an order without going before the judge again.

Amend 2015 Solid Waste Ordinance

Human Resources Director, Kevin Beals, presented the item. Mr. Beals stated recently the 2023-2024 Residential Solid Waste Franchise Renewal during that process, both franchisees requested amendments and/or adjustments to the Solid Waste Ordinance. Mr. Beals stated Advanced Disposal Services and Deep South Sanitation have both asked regarding the below franchisee's proposed changes: Increase the basic service not to exceed fee from \$20.00 per month to \$25.00 per month. (Solid Waste Ordinance Section 3.1.(c)) & (Franchise Agreement -Item Number 14 (Pricing for Basic Service)). Adjust Hours of Operation of Collection Centers from 42 hours per week to 35 hours per week. (Change schedule from Friday, Saturday, and Monday 7:00 a.m. - 7:00 p.m. to 8:00 a.m. - 6:00 p.m. and Sundays from 1:00 p.m. - 7:00 p.m. to 1:00 p.m. to 6:00 p.m.). Solid Waste Ordinance Section 3.6. & Franchise Agreement - Item Number 23 (Hours of Operation of Collection Center). Vice Chairman Wisenbaker asked regarding the wording stating an increase due to labor and fuel costs and stated there is also a fuel surcharge being charged, Mr. Beals responded commercial businesses are not being monitored, this relates only to residential solid waste. Commissioner Marshall asked regarding the amount for the residents, Mr. Beals answered that currently there has not been an amount given. Chairman Slaughter asked regarding any concerns the Commission may have regarding this request and stated that with the previous increase of only \$3.50 in eight years, he has no issue with increasing up to \$25.00 per month. Chairman Slaughter stated this request could occur again in a year to increase or decrease the amount. Vice Chairman Wisenbaker suggested there needs to be a change in the wording regarding the difference between residential and commercial surcharges, Mr. Beals responded that language could be changed within the Solid Waste Ordinance.

BID

Brookridge Drive Grading, Drainage, Base, and Paving

Director of Engineering Services, Chad McLeod, presented the item. Mr. McLeod stated that Brookridge Drive is located south of Hahira and is approximately 0.42 miles long. Mr. McLeod stated staff received two bids, the Scruggs Company in the amount of \$647,831.28 and Reames and Son Construction in the amount of \$768,703.15.

Bid for a Crop Sprayer for the Utilities Department

Purchasing Agent, Amy Woods, presented the item. Mrs. Woods stated bids were solicited for a new crop sprayer for the Utilities Department, to be used at the Land Application System (LAS). Mrs. Woods stated one bid was received that met specifications from Flint Equipment Company in the amount of \$36,750.00.

REPORTS - County Manager

Extension Office Update Presentation by Joshua Dawson (Work Session)

County Manager, Paige Dukes, introduced Mr. Joshua Dawson, Agriculture and Natural Resources Agent with the Lowndes County Extension Office. Mr. Dawson thanked the Commissioners for their support and presented a brief update, with information packets given to the Commissioners detailing the Lowndes County Extension Office operations in the area. Additionally, Mr. Dawson invited the Commission to attend the 4-H Banquet being held May 18th at the Lowndes County Extension Office. Vice Chairman Wisenbaker asked regarding the satsumas crop, if it is close to maxing out as far as production, Mr. Dawson stated that was a problem last year and due to the cold weather this year, there is a concern since we currently have 3,000 acres of satsumas planted. Commissioner Marshall asked regarding the training events, if there was a cost to attend, Mr. Dawson responded there is no cost to attend. Chairman Slaughter thanked Mr. Dawson for the update and for his continued service to Lowndes County.

ADJOURNMENT

Chairman Slaughter stated the rotation of the Vice Chairmanship is now changing to Commissioner Mark Wisenbaker. Commissioner Orenstein made a motion to adjourn the work session meeting, Commissioner Griner second. Chairman Slaughter adjourned the meeting at 9:07 a.m.

MINUTES

APPOINTMENTS

Lowndes County Board of Health

County Manager, Paige Dukes, presented the item. Dr. Randy Smith's term has expired and he has not expressed a desire to continue to serve. Mrs. Dukes stated Ms. Brenda Mims has been recommended for the seat. Commissioner Evans nominated Mrs. Brenda Mims for appointment. There being no other nominations, Mrs. Brenda Mims was appointed by acclamation.

Valdosta-Lowndes County Zoning Board of Appeals (ZBOA)

County Manager, Paige Dukes, presented the item. Mrs. Dukes stated there are two County Zoning Board of Appeals members whose terms are expiring on May 7, 2023. Mr. Marion Ramsey and Ms. Victoria Copeland have both expressed a desire to continue to serve. Commissioner Orenstein stated he spoke with Mac McCall yesterday and he recommended them highly. Commissioner Orenstein nominated Mr. Ramsey and Ms. Copeland for reappointment. There being no other nominations, Mr. Ramsey and Ms. Copeland were reappointed by acclamation.

South Georgia Regional Library Board

County Manager, Paige Dukes, presented the item, Mrs. Dukes stated Dr. Darlene Ridley has stated she will no longer be able to serve on the board. Ms. Jane Peebles would like to be appointed to fill the unexpired term and has expressed a desire to serve on this board. Commissioner Griner nominated Ms. Jane Peebles for appointment. There being no other nominations, Ms. Jane Peebles was appointed by acclamation.

PUBLIC HEARING

REZ-2022-10 The Campus Transitional Care Facility, 2193 Howell Road, E-A to P-D, Well & Septic, ~23 acres

County Planner, J.D. Dillard, presented the item. Mr. Dillard stated this request is for E-A to P-D zoning on Howell Road in an agricultural-character area, with some wetlands on the northend of the property. Mr. Dillard stated that it is currently heavily wooded and there is one house on the front left of the property located at 2193 Howell Road. Mr. Dillard stated the request for P-D is for the site plan for a recovery residence or sober living facility, as stated in the letter of intent. Mr. Dillard stated the Planning Commission recommended denial. Chairman Slaughter explained each side will get ten minutes and following after both sides are heard, each side will get two minutes to rebuttal.

Savannah Baker, 4046 Old Naylor Road, spoke against the request. Ms. Baker stated this request should be denied due to spot zoning. Ms. Baker gave the definition of spot zoning and gave examples of court cases regarding spot zoning. Ms. Baker stated at the last commission meeting held on March 28, 2023 the vote was tabled until the April 11, 2023 commission meeting. Ms. Baker stated there was no new public notice that was published for today's meeting in the newspaper or new signage at the property for today's meeting. Ms. Baker believes this was insufficient notice for the public and the community has expressed concerns with over 500 letters in opposition and many facts and statistics cited. Ms. Baker stated this rezoning would be unlawful and a complete disregard for the voice of the people represented. James Walker, 4060 Boring Pond Road, spoke against the request. Mr. Walker stated he has lived on Boring Pond Road for twenty-eight years and he is concerned there will be more traffic, growth with the water and sewer, and asks that the rezoning request be denied. Blake Howell, 3417 Boring Pond Road, spoke against the request. Mr. Howell stated he has lived on Boring Pond Road for thirty-eight years and this rezoning goes against the wishes of the community. Mr. Howell stated he has spoken to many citizens within Districts 3 and 5 and this facility goes against the wishes of the community. Mr. Howell stated the Planning Commission denied rezoning due to going against the character area. Mr. Howell asked the Commission to please deny this rezoning request. Mr. Howell stated Redeemed Living could find a more suitable location and respect the wishes of the community, citing do unto others as you would have done unto you. Brent Moore, 3850 C L Moore Road, spoke in favor of the request as the applicant and owner of Redeemed Living. Mr. Moore stated he would like to address a few concerns presented to him within the last twelve months. Mr. Moore stated there are concerns with this facility not being regulated and Mr. Moore stated they are GARR certified (Georgia Association of Recovery Residences), meaning their procedures and guidelines would be followed including passing inspections and offering a suitable living for someone in the program. Mr. Moore stated as part of the GARR certification there is a requirement to drug test for those who will be staying in the facility. Mr. Moore stated he met with Sheriff Paulk and the Sheriff's Deputies will be allowed to access the property with drug dogs at random. Mr. Moore stated all residents will submit a background check and no one will be allowed with a felony charge or sexually related charges. Mr. Moore stated there was a person who spoke in favor of this request one of the previous meetings and he was charged with a battery charge, but not convicted. Further, Mr. Moore stated this individual went through the program, works for a local business and is now working with

the City of Valdosta Fire Department. Mr. Moore mentioned he was given a second chance and he would like to help and give others hope.

Opposition - Rebuttal:

Savannah Baker, 4046 Old Naylor Road, stated it's not that their community is against helping people, the request is that it be in a different location in Lowndes County. Ms. Baker stated this is not the best location for this facility since there are no local, state or federal regulations. Ms. Baker stated GARR is a membership program and there are no on-site visits. Regarding allowing violent people into their program, there have been people allowed in the program with a violent history.

Blake Howell, 3417 Boring Pond Road, stated their community is not villains, they are worried about safety and protecting investments. Mr. Howell stated that these residents could come invest and purchase property to build homes and he would support them.

In Favor - Rebuttal:

Brent Moore, 3850 C L Moore Road, stated there may have been someone in the past before the background checks were implemented with a violent history.

Joseph Lelonek, 603 West Park Avenue, spoke as a current resident living in the Redeemed Living House. Mr. Lelonek stated this house gave him an opportunity, he came from Tennessee, homeless, living on the street, with no money. Mr. Lelonek stated he now has a job due to the help of Redeemed Living. Mr. Lelonek stated he did not come through the system, he came on his own to get help.

Commissioner Orenstein asked about the history and the "what if's", the facts surrounding where they came from, currently at 603 West Park Avenue, how many calls for emergency 911 calls. Mr. Brent Moore responded there has been one instance at 603 West Park Avenue in which the administrators initiated the 911 call due to the resident being intoxicated. The Valdosta Police Department dispatched two police officers to be on scene, since the resident was asked to leave the facility. Commissioner Orenstein asked how long has the house on Park Avenue been occupied, Mr. Moore responded almost three years. Mr. Moore stated previously there was a house located at 401 Danube Circle in Schroer Estates, same issue, resident was drunk, the police were called and he was asked to leave. Commissioner Marshall asked to verify the legal meeting requirements regarding the notice/signage which someone mentioned earlier, County Attorney, Walter Elliott responded notice was given of your prior meeting and at that meeting notice was given to those in attendance that the meeting was tabled. Chairman Slaughter stated the meeting was given at the proper time, the hearing was tabled, no point in readvertising due to tabling. Commissioner Marshall asked, based on the current zoning now, what could not be achieved in their proposal, Mr. Dillard responded based on the current zoning the overall density of the houses shown on their site plan, it is allowed for single family dwellings on E-A zoning, possible accessory dwelling for family members and with the property being twenty-three acres could be subdivided into four, five acre tracts and a house on each property. Commissioner Griner made a motion to approve the rezoning request as presented, Vice Chairman Wisenbaker second. Commissioners Orenstein, Griner and Vice Chairman Wisenbaker voted in favor of the request, Commissioners Evans and Marshall opposed. Motion carried.

County Attorney, Walter Elliott, stated it is written this way because operating a collection center is an alternative to curbside. Commissioner Griner wanted to verify that it was not an option. Commissioner Griner made a motion to approve the request as presented, Vice Chairman Wisenbaker second. All voted in favor, no one opposed. Motion carried.

REPORTS - County Manager

County Manager, Paige Dukes, reminded everyone this week is National Animal Control Officer Appreciation Week and National Public Safety Telecommunications Week and thanked the Commission for their support of these departments. Mrs. Dukes stated Public Information Officer, Meghan Barwick, will be attending an active shooter training; the Lowndes County Sheriff's Office was able to get in a large class that is supported by the FBI and used nationwide to train on active shooters with training being held today, tomorrow and Thursday. Mrs. Dukes commended Public Works Director, Robin Cumbus and her staff for the set up at the Lowndes County Civic Center due to a change of venue with this training. Mrs. Dukes stated there is pipe being installed next door and that project is progressing. Next Thursday, Leadership Lowndes will hold their Economic Development Day. This Saturday at 7:00 a.m. Chairman Slaughter, Commissioner Evans and Paige Dukes will be attending the Spring Run with the Girls on the Run program being held at Wiregrass Georgia Technical College. This program empowers young girls in our community.
